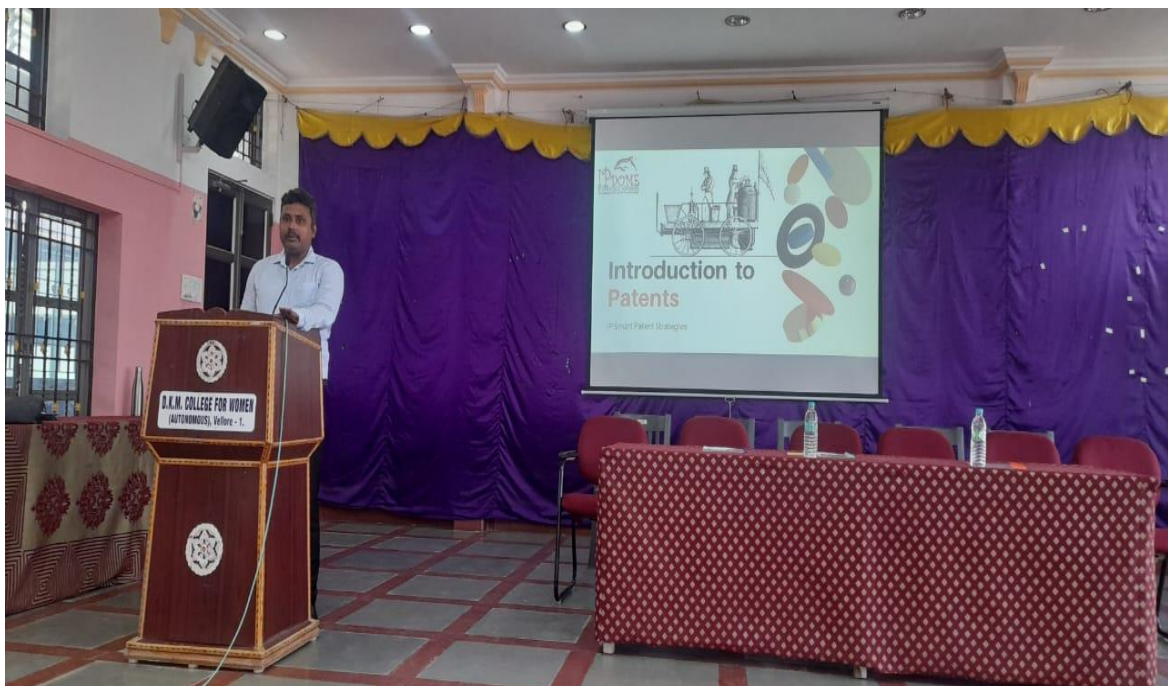

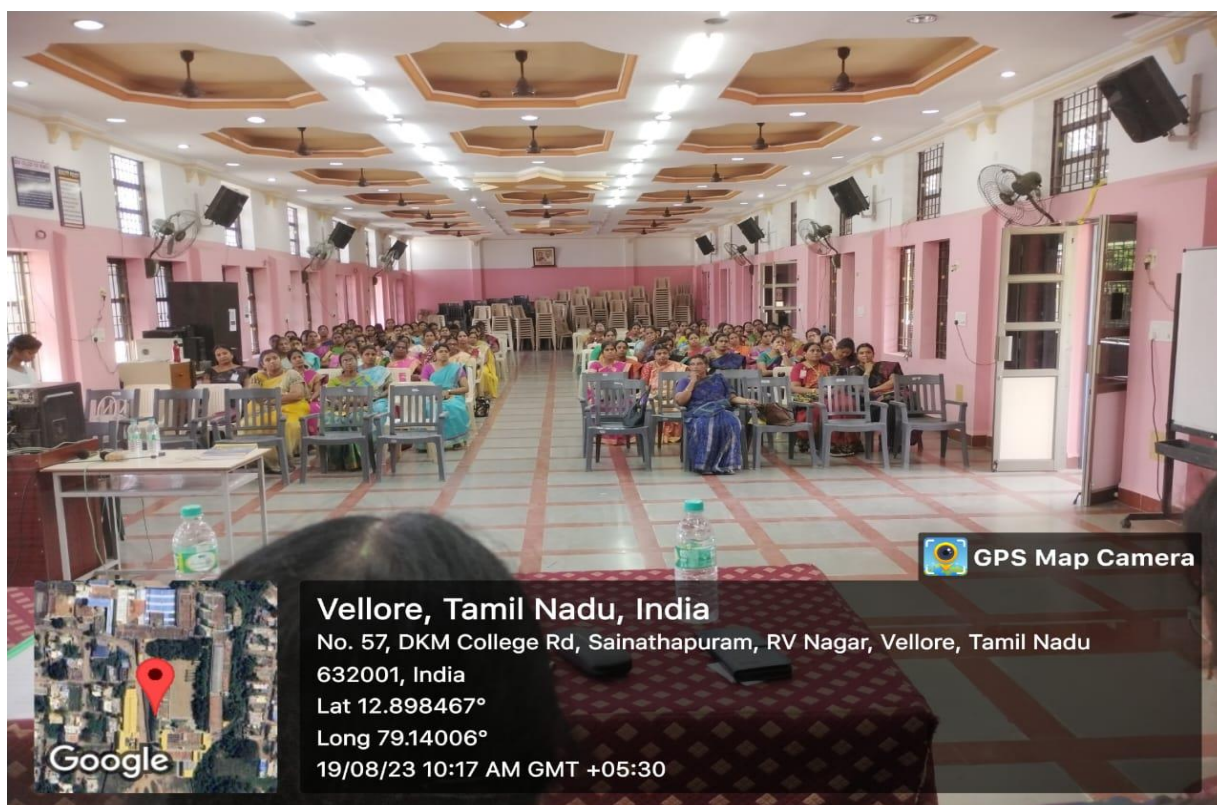

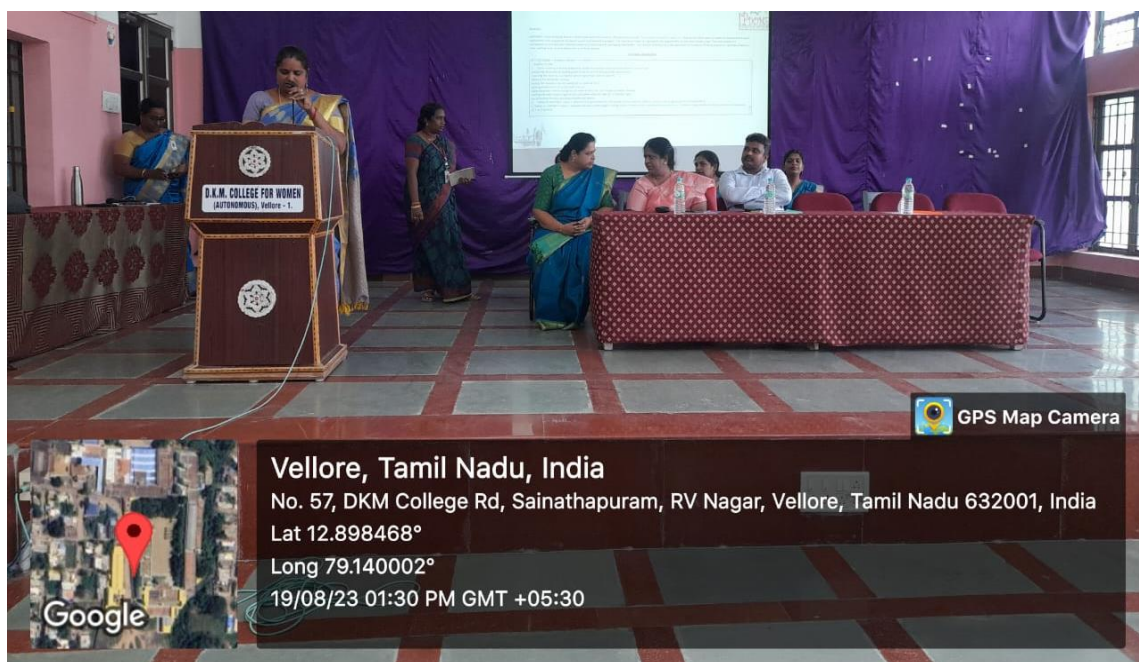

FEEDBACK FROM PARTICIPANTS – REPORT

The theme of the Faculty Development Programme is on Drafting and Filing of Patents. It means Patent searches are extremely important for managing and protecting intellectual property. There are many different kinds of searches, including searches for previous art, patentability, validity/invalidity, innovation, and FTO/infringement. To find out whether goods or patents are violating your non-terminated patented invention, infringement searches are carried out. Analyses of freedom to operate aid in launching the product without infringing on the intellectual property of others.

Overall Evaluation of the Programme

- 78% of the participants felt very good about the organisation of the programme and 20% of the participants felt excellent and 2% of the participants felt satisfactory.
- 65% of the participants felt very good towards the interaction with the resource person, 32 of the participants felt excellent and 3% of the participants felt it was a good experience
- 80% of the participants felt very good about the quality of the lecture content, 13% of the participants felt it was excellent and 7% of the participants felt it was good quality of the lecture content.
- 56% of the respondents felt very good about the skill at the beginning of the FDP and 44% of the participants felt good about their knowledge at the beginning of the FDP.
- 76% of the participants felt very good about the knowledge at the end of the FDP and 24% of the participants felt excellent about the skill at the end of the FDP.
- Overall, the participants gained more information about the process drafting and filing of patents with an excellent discussion with the eminent resource

person throughout the programme also they felt more satisfactory in the aspect patent filing guidelines and commercialize techniques through the session.

- Overall, the participants found the programmes well organised and informative and was timely followed. It provides the greatest opportunity to the teaching faculty to empower and enrich their skills in filing the patents. The theme of the FDP is highly relevant in the current education scenario. Many participants expressed that the technical Session empowered them to strengthen the process of drafting and filing of patents. So, the participants suggested that the programme may be organised for continuously two days because they require more valuable and updating information about patent filing.
